The Royal Government of Cambodia (RGC) has received a Loans 3006/3007 and Grants 0349/0350-CAM from the Asian Development Bank toward the cost of Climate-Resilient Rice Commercialization Sector Development Program, and it intends to apply part of the proceeds of this Loan and Grant to payments under the Contract for works as follow:

The Ministry of Economy and Finance represented by the Program Management Office (PMO) now invites sealed bids from eligible and qualified bidders for Construction of Paddy Drying and Storage Facilities and Supply and Installation of Equipment for Rice Mills in Battambang, Kompong Thom, and Prey Veng Province. The construction period is 10 months as shown in the bidding document.

3. Procurement will be conducted through National Competitive Bidding Procedures as specified under the laws and regulations governing public procurement within the Kingdom of Cambodia, in accordance with the Procurement Manual for Externally Financed Project/Programs in Cambodia, Update Version May 2012 and in accordance with the Finance Agreement.

4. This invitation is open to all eligible bidders from eligible source countries as described in the bidding document.

5. Interested eligible bidders may obtain further information from Ministry of Economy and Finance/Program Management Office (PMO), Rice-SDP, and inspect the Bidding Documents at the address given below **from 9:00 am to 4:00 pm** (Cambodia Standard Time), before the deadline of submission of bids.

The Government of Cambodia and/or the Funding Agency will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Government of Cambodia and/or the Funding Agency respectively, if it at any time determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
