#### A. INTRODUCTION

- 1. The Climate Resilient Rice Commercialisation Sector Development Program (Rice-SDP), which commenced in November 2013, supports the implementation of the 'Policy on the Promotion of Paddy production and Rice Export' of the Royal Government of Cambodia (RGC). It is designed to help transform the predominantly subsistence rice sector into a commercially oriented one by improving household and national food security and expand rice export through (i) removing the legal and regulatory constraints inhibiting rice commercialization; (ii) improving productivity of paddy crops and consistency in quality of milled rice; (iii) enhancing rice value chain support services; and (iv) addressing risks of climate change through mitigation and adaptation.
- 2. The Quarterly Progress Report (QPR) for Q3 (July-September), 2017 provides a description of the progress that has been achieved during this quarter. The PPMS that is being developed is progressively incorporated into the QPRs initially through the inclusion of the Activity Monitoring Framework. Initiatives are being made to put in place a defined approach for streamlining the data collection and reporting of the PIO and NIO teams. The QPR also includes a summary of the financial progress although the rates of disbursement remain low due to the slow progress in the implementation of many activities. This is expected to improve significantly towards first half of 2018 as more contract awards are made which will also boost the disbursement rate.

#### C. PROGRAM PURPOSE AND IMPACT

- 3. The Climate Resilient Rice Commercialization Sector Development Program (Rice-SDP) comprises a policy-based program loan together with other loans and grants from ADB sources. The Rice-SDP impact will be increased net incomes of stakeholders along the rice value chain. The outcome is enhanced production of quality rice in Cambodia while preserving the natural resource base.
- 4. The Rice-SDP will address key high priority and strategic measures stated in the Rice Policy to improve national food security and expand rice export through (i) removing legal and regulatory constraints inhibiting rice commercialization; (ii) improving productivity of paddy crops and consistency in quality of milled rice; (iii) enhancing rice value chain support services; and (iv) addressing risks of climate change through mitigation and adaptation. The Rice-SDP has the following six outputs:

# Output 1 - A Conducive Legal and Regulatory Environment established to facilitate Climate-Resilient Rice Commercialization

✓ This output focuses on legal and regulatory reforms that (i) promote production and distribution of improved quality seed; (ii) strengthen agricultural land management; (iii) strengthen farmers' organizations and promote contract farming; and (iv) facilitate the domestic trading and export of milled rice.

#### Output 2 - Agricultural Land-use Zoning improved

✓ This output comprises: (i) establishing land-use zones; (ii) updating rice ecosystems
and soil classification maps for identification of higher yielding rice growing areas; (iii)
incorporating Commune Agro-Ecosystem Analyses into commune land-use planning;
and (iv) developing the capacity of Ministry of Agriculture, Forestry and Fisheries
(MAFF) and Ministry of Land Management, Urban Planning and Construction
(MLMUPC) at the national and sub-national levels to undertake joint work in relation to
agricultural land-use planning.

#### Output 3 - Climate Resilient Rice Value Chain Infrastructure developed

✓ This output comprises high priority investments in three major rice-producing provinces
- Battambang (BTB), Kampong Thom (KPT), and Prey Veng (PVG). The investments
include: (i) rehabilitation and climate proofing of irrigation systems; (ii) construction of
paddy drying and storage facilities; and (iii) construction of seed cleaning, drying,
grading and storage facilities. The investments have been identified and prioritized
based on provincial development priorities.

# Output 4 - Rice Value Chain Support Services Enhanced to Improve Quality of Cambodian Rice

✓ This output comprises: (i) improving the availability and quality of commercial rice seed; (ii) upgrading technical extension material to guide production in the four main rice crops; (iii) capacity building (technical and financial) of mill managers and operators; and (iv) facilitating access to credit by farmers, traders, and millers.

#### Output 5 - Weather-indexed Crop Insurance (WICI) Piloted

✓ This output comprises: (i) undertaking a detailed feasibility study to determine the
appropriateness of a weather-indexed crop insurance scheme; (ii) designing the
operational parameters, product penetration plan, and institutional arrangements; and
(iii) piloting the scheme in selected areas in three program provinces.

#### **Output 6 - Efficient Program Management and Implementation**

✓ This output comprises: (i) effective program management; (ii) capacity building of the Program Management Office (PMO) and each National Implementation Office (NIO) and Provincial Implementation Office (PIO); and (iii) coordination between policy development and investment activities.

#### D. SUMMARY OF PROJECT STATUS

Status of project scope/implementation arrangements compared with those in the report and RRP, and whether major changes have occurred or will need to be made:

The Program is making better progress and the capacity of the IAs and their familiarity with ADB project procedures is improving. The scope of the Program remains in line with those of the RRP to date although there have been changes made to the implementation approach in some cases, notably for the Paddy Drying and Storage (PDS) facilities including the procedure for the identification of the sites for these facilities and the provision of concessional loans for their construction. The implementation arrangements are also being modified in the sense that the Program Implementation Consultant (PIC) contract was closed early (on 15 May 2017), and replaced with necessary international and national individual consultants

Assessment of the likelihood that the Project purpose will be met in part or in full, and whether remedial measures are required based on the current project scope and implementation arrangements:

It is too early to make any definitive judgement on this. The Program has made continued progress so far and the compliance conditions for the Program loan fund release are reasonably well on track although the conditions relating to land management and plant protection require some additional time to complete and a request for extension of the loan duration has been made. Consultants are providing essential technical support to the IAs in implementation of the program. The AWPB 2017 that has been developed was very ambitious in scope and efforts are being made to come up with clear guidelines for the implementation of planned activities during the year. Similarly, continued improvements to the PPMS are being made to enable it to tracking performance.

An assessment of changes to the key assumptions and risks that affect attainment of the development objectives:

Of the risks identified in the RRP the most challenging issue concerns "the inherently complex nature of sector development program modality and limited technical skills and resources to implement legal and regulatory reforms". Consultants recruited under the program are assisting the government in implementing legal and regulatory reforms for compliance with the release of the Second Tranche in Q4 2017. The current situation is summarised in Annex 1.

Other program developments, including monitoring and reporting on environmental and social requirements that might adversely affect the project's viability or accomplishment of immediate objectives:

At this early stage, no significant factors have emerged which might adversely affect the project's long-term viability. The accomplishment of immediate objectives is partly constrained by the issues that are described in Section L.

#### E. UTILIZATION OF FUNDS

5. The Climate Resilient Rice Commercialization Sector Development Program (Rice-SDP) is funded through loans/grants from ADB with a total amount of USD 63.3 million, together with a Program loan amounting to USD 24 million. The breakdown is as follows:

- 6. The Ministry of Economy and Finance opened the first generation imprest account (FGIA) at the National Bank of Cambodia (NBC) and the PMO opened a project account in the ACLEDA Bank PLc. so as to use the project funds. The sub-accounts were also opened at the NIOs and PIOs at the ACLEDA Bank Plc. for smooth flow of project funds to the provinces.
- 7. As of 30 September 2017, a total project fund of \$ 7,672,591.62 has been disbursed out of which \$3,782,164.65 is from Loan proceeds, \$2,705,343.22 from Grant proceeds, and \$1,185,083.75 from the counterpart fund.
- 8. As for the program loan, the first tranche amounting to \$12.3 million (equivalent SDR 7.98 million) was released from ADB in December 2013. The second and final tranche is expected to be released by end of this year once the required twelve policy conditions are complied with. The cumulative disbursement for each funding source as of 30 September 2017 is as follows:

9. As of end of September 2017, the overall progress of the project activities is estimated at about 36.13% against the elapsed loan/grant period of 60.78%, against the total disbursement of 23.00% of the total fund.<sup>1</sup>

#### F. SUMMARY OF PHYSICAL IMPLEMENTATION PROGRESS UPTO Q3 2017

- 10. **Output 1:** Under this output, the program has complied with the policy conditions for the first tranche. For the second tranche, there are a total of twelve policy conditions. So far the program has achieved 8 policy conditions namely that: (i) MAFF will have issued the Cambodian Seed Policy; (ii) MAFF will have issued the National Seed Standards; (iii) MAFF will have issued the Prakas on Procedures for Providing Seed Quality Certification; (iv) MAFF will have issued the General Introduction to the Examination of Distinctiveness, Uniformity and Stability (DUS) of new varieties of Plants; (v) MAFF will have issued the Guidelines for the Conduct of Tests for DUS of Rice; (vi) the Government will have issued the Land Policy "White Paper", including a chapter on Land and Gender Policy; (vii) MAFF will have submitted the draft Law on Agricultural Cooperatives to the National Assembly; and (viii) Ministry of Handicraft (MIH) will have issued the standards for two varieties of Cambodian milled rice, Phka Rumdoul and Phka Chan Sensor.
- 11. Significant progress has been made on the remaining four policy actions concerning (i) adoption of the national action program to combat land degradation in Cambodia; (ii) draft Law on Plant Protection and Phyto-sanitary Measures; (iii) draft Law on Management and Use of Agricultural Land; and (iv) Guidelines for establishing Agricultural Land Use Zones. The draft Agriculture Land Law is put for further consultations and deliberations before being submitted to Council of Ministers. It is expected that all conditions will be complied with by December 2017 including the English translation of the required documents. However, to avoid any issue arising out of the delayed submission, a request has been submitted by the EA for an extension of the loan duration by 6 months to end on 30 June 2018 from the current 31 December 2017. The request is under consideration of ADB.
- 12. **Output 2:** The MAFF/NIO team completed the Training of Trainers (ToT) for the conduct of the Commune Agro-Ecosystem Analysis (CAEA) for district extension staff in each province. Three (3) CAEA, one in each province, is prepared under this ToT program through learning by doing approach. A total of 110 farmers, of which 22 are women, participated in these training. Based on the experience and lessons learned, Guidelines and Letters of Agreement (LoA) for implementation CAEA is prepared by MAFF and endorsed by ADB. The field work in each province for the preparation of the CAEAs will commence in October 2017 with a target to complete AEAs for 87 communes before the end of Q4 2018. The training workshops for Commune Land Use Plan (CLUP) was completed by the MLMUPC in all the target provinces. A total of 230 farmers, of which 19 are women, participated in these training. Recruitment of a service provider for preparing CLUP for 90 communes is completed with the signing of contract in September 2017. The mobilization of the service provider is expected in mid-October 2017. As for the rice ecosystems and soil classification maps update, training was conducted on GIS procedures and the use of GPS technologies for MAFF/NIO as well as

other GDA staff and there was a follow up training provided to provide more in-depth knowledge following the success of the 1<sup>st</sup> training. One provincial-based training workshop on GIS was conducted in BTB province for staff from the PDA. Concept notes are now being prepared for implementation of the rice ecosystems and soil classification maps update. Once the concept notes are finalized and endorsement from ADB received, the activities will be implemented on the ground. As of now, MAFF has completed trainings on soil survey and classification in 2 target provinces with a participation of a total of 56 participants, of which 11 were women.

- 13. Output 3: The MOWRAM/NIO is rehabilitating six irrigation sub-projects benefitting around 46 villages, 10,343 households including 1,519 female headed households. These six subprojects will create a combined potential irrigated area of 10,373 hectares. One of the subprojects is completed (100%) and another is at 70-80% completion stage. Implementation of the rest four subprojects has just started. A further 3 sub-projects are under bid preparation and feasibility study stage. Climate resilient design features for each sub-project is incorporated. The procedures for the implementation of the Paddy Drying and Storage (PDS) facilities have been revised following extensive discussions between MAFF and the PMO/MEF and the outcome of the PPP forum which was conducted with the participation of wide representation from the rice milling sector. A Concept Note describing the approach is prepared in which the procedures for supporting the PDS facilities is described. The Concept note is endorsed by ADB. Advertisement for EoIs from rice miller was issued in March 2017. Eight millers have expressed their interests and evaluation is on-going. Seed processing centres, one in each target province, will be established to serve as one stop shop for quality seed, post-harvest services, farmer consultations, and trainings and demonstrations. The MAFF has recruited a firm to do the feasibility study (FS) for seed processing centres and PDS facilities and the firm is expected to be mobilized in mid-October 2017. The Laser land levelling activity is expected to start in Battambang and Prey Veng by coming dry season (end of November 2017). All PIOs have been instructed to complete procurement process during the rainy season so that the work can be undertaken during the upcoming dry season.
- 14. Output 4: The MAFF/NIO awarded the contract for the supply of equipment for the seed testing laboratory at MAFF/GDA and the equipment had been delivered. A Rice Seed Production Manual including formats for Letters of Agreement (LoAs) for all types of seed production -Foundation Seed, Registered Seed and Certified Seed, and Farmers Field School for seed production - was drafted so as to adopt a holistic approach towards different types of Rice Seeds Production through engagement of relevant stakeholders. LoAs were signed with MAFF agriculture stations in each target province and 18 tons of registered rice seed were produced and sold to Agricultural Cooperatives (ACs) in 2016. Using the seed, the ACs have produced certified rice seeds and sold to farmers/traders/rice millers for producing quality paddy. For 2017, MAFF is now procuring foundation rice seed to produce registered rice seed. In BTB and PVG there were a total of 14 Farmer Field Schools (FFSs) conducted in association with ACs that are engaged in rice seed production. All the FFSs were conducted the conduct of a field day and a total of 360 farmers including 125 women participants participated in these training. Field visits were made to each PIO by the MAFF/NIO and consultants to gather information from the ACs on their seed production capacities. An assessment report was prepared showing the strength and weakness of the ACs and their capacity building needs. Plans are being prepared for capacity building of ACs.

- 15. **Output 5:** A service provider is recruited for conducting feasibility study of Weather Indexed Crop Insurance (WICI). The WICI consultants are mobilized in September 2017 and will complete the initial FS by Q4 2017. Based upon a satisfactory outcome, pilot studies will be designed to commence implementation in 2018.
- 16. **Output 6:** The contract of consulting firm supporting program implementation was closed on 15 May 2017 upon mutual agreement between EA and the firm. Recruitments of necessary individual consultants needed for program implementation is being undertaken. The PPMS which was developed is being revised to reflect the changes to the GAFSP indicators. Suitable and easy to use monitoring formats are being developed so that the IAs can collect useful data under Rice-SDP. The Annual Work Plan and Budget (AWPB) for 2017 was prepared and approved, and implementation of the program is being done following the approved plan.

#### G. PROGRESS AND ACHIEVEMENTS DURING Q3 2017

17. The main accomplishments during Q3 can be summarised as follows:<sup>2</sup>

#### **Output 1: Conducive Legal and Regulatory Environment**

- 18. The status of the progress of the compliance with the remaining 8 conditions (as of Q2) for the release of the 2<sup>nd</sup> tranche of the Policy Loan (3006) is summarised as follows:
  - ✓ **Promoting local seed production and distribution:** GDA submitted the final drafts of the documents relating to the four policy conditions relating to seed (National Seed Standards, Prakas on Procedures for providing Seed Quality Certification, General Introduction to the Examination of Distinctness, Uniformity and Stability of New Varieties of Plants, and Guidelines for the Conduct of Tests for Distinctness, Uniformity and Stability of Rice) and MAFF has approved those documents. The four policy documents are issued in July 2017 and compliance with the original formulation of the policy conditions is achieved.
  - ✓ Strengthening agricultural land management: GDA has submitted the draft Law on Management and Use of Agricultural Land to MAFF on 9 June 2017. MAFF has carried out additional external consultations due to some evolving situations and draft law will be submitted by Minister of MAFF to Council of Ministers by end of October 2017. The draft final of the National Action Plan to combat Land Degradation in Cambodia has been prepared and submitted to MAFF in December 2016 which was passed at MAFF on 09 February 2017. The draft was finalized by revising the draft's format/layout and incorporating the rational and submitted to Council of Ministers (from Minister of MAFF to Council of Ministers) in September 2017. GDA has completed the draft final of the Guidelines for Establishing Agricultural Land Use Zones. The guidelines are passed in the final technical meeting conducted at GDA on 5 July 2017 and the final draft is planned to be approved by the Director General, GDA of MAFF and issued in September 2017.
  - ✓ Improvement of plant protection and phyto-sanitary restrictions: GDA has submitted the draft final of the Law on Plant Protection and Phyto-sanitary Measures to MAFF on 27 October 2016. MAFF has since conducted 9 review meetings, finalized

the draft Law, and submitted the draft to Council of Ministers (from Minister of MAFF to Council of Ministers) in August 2017.

#### **Output 2: Agricultural Land-Use Zoning Improved**

#### Output 2.1: Undertake Commune Agro-Ecological Analysis

19. During the quarter, the Commune Agro-Ecosystem Analysis (CAEA) Letters of Agreement (LoA) for implementation CAEA was finalized after budget estimates for each target commune was prepared which was then consolidated at province level and at national level. Specific accounts were opened at PDAFF to receive the project fund for the implementation of the CAEAs. The LoAs were signed between the MAFF/NIO and PDAFF and field work in each province for the preparation of the CAEAs will commence in October 2017.

#### Output 2.2: Incorporation of the CAEAs into the Commune Land Use Plans

20. The training workshops on the Guidelines for Commune Land Use Plan (CLUP) implementation was completed by the Ministry of Land Management and Urban Planning (MLMUPC) in all target provinces. During the quarter, the training workshops was held in Prey Veng (PVG) with a participation of a total of 72 participants, of which 6 were women. Recruitment of a service provider for preparing CLUP for 90 communes is completed with the signing of contract in September 2017. The mobilization of the service provider is expected in mid-October 2017.

#### Output 2.3: Rice ecosystem Mapping

21. The updating of maps related to rice ecosystems and soil classification will be undertaken soon to identify higher yielding rice growing areas in Cambodia. Concept notes are now being prepared for implementation of the rice ecosystems and soil classification maps update. Once the concept notes are finalized and endorsement from ADB received, the activities will be implemented on the ground.

#### Output 3: Climate Resilient Rice Value Chain Infrastructure developed

#### Output 3.1: Rehabilitation and climate proofing of irrigation systems

- 22. The MOWRAM awarded contracts for rehabilitation of 2 core irrigation sub-projects that will benefit around 18 villages, 6,014 households including 796 female headed households, and create a combined irrigation potential of 2,800 hectares. Out of the two, one subproject is completed (100%) and the other one is at 75% completion.
- 23. The MOWRAM has awarded contracts for 4 more sub-projects (1. Anlong Char, 2. Chamcar kuoy, 3. Ta Mao, and 4. Anlong Run) that will cover 28 villages, 4,329 households including 723 female headed households, and create a combined irrigation potential of 7,573 hectares. Implementation of these subprojects will start in October 2017.
- 24. The MOWRAM is currently preparing bid for 1 irrigation subproject and feasibility studies (FSs) for 2 subprojects. Rest of the 19 pre-screened irrigation sub-projects will be considered for rehabilitation based on the budget availability and according to the priority. Climate resilient design features for each sub-project is incorporated.

#### Output 3.2: Construction of paddy drying and storage (PDS) facilities

25. A Concept Note describing the Public-Private Partnership (PPP) approach to be adopted for implementation of the Paddy Drying and Storage (PDS) facilities was prepared by PMO and endorsed by ADB. Advertisement for EoIs from rice millers to establish PDS is completed and 8 EOIs have been received. The EOI evaluation is on-going. The MAFF has completed the recruitment of a firm to conduct the FSs for the seed processing and PDS facilities in September 2017. The firm is expected to be mobilization in mid-October 2017.

#### Output 3.3: Construction of seed cleaning, drying, grading and storage facilities

26. The MAFF/NIO has proposed that the seed processing centres be established at the site of one agriculture station in each province to serve as one stop shop for quality seed, post-harvest services, farmer consultations, and trainings and demonstrations. The aim is also to provide services to the ACs engaged in seed production. The MAFF/NIO has come up with the 1<sup>st</sup> draft of a Concept Paper describing the revised mode of operation of these facilities and providing an analysis of the operating costs involved and how these will be met. Once the concept paper is finalized, it will be submitted to ADB for necessary endorsement before proceeding further.

# Output 3.4: Contract services for implementation of sub-project associated initiatives

- 27. The Concept Paper on Land Levelling was prepared, reviewed and amended to include the information gathered from the consultations with farmers in the sub-project areas. The PIOs are tasked with the responsibility for implementing this activity and they received guidance from the PMO on the bidding procedures. The recruitment of service provider for Land Levelling has been completed in two province (Battambang and Prey Veng). The third target province (Kampong Thom) is finalizing the demand and will soon commence the preparation of bidding documents. Field implementation of the activity is expected to start in November 2017.
- 28. Project Activity Proposals are prepared in BTB, KPT and PVG provinces for FWUC formation, strengthening of ACs, and for delivery of agricultural extension services. The

proposals for BTB and PVG provinces are finalized at the PIOs and submitted to the PMO for review and approval. The PMO has endorsed these proposals and implementation has started from August 2017.

#### Output 4: Enhanced rice value chain support services

#### Output 4.1: Increased availability of quality rice seed

- 29. For 2017, MAFF is now procuring foundation rice seed to produce registered rice seed. Letters of Agreement (LoAs) were signed by MAFF/NIO with agriculture stations to produce 16 tons of registered rice seed and sale to Agricultural Cooperatives (ACs). Plans for establishment of seed centre in one agriculture station in each province has been drawn so that these stations can provide services to the ACs for drying, cleaning and processing of the certified rice seed.
- 30. In KPT, a total of 6 Farmer Field Schools (FFSs) is being conducted in association with ACs that are engaged in rice seed production. Under the associated project initiatives, BTB is conducting a further 10 FFSs. Implementation of these 16 FFSs is on-going.
- 31. After the assessment report on ACs prepared showing the strength and weakness of the ACs and their capacity building needs, plans are now being prepared for capacity building of ACs.

#### Output 4.2: Expand and develop technical extension services

32. One Post-Harvest Training was conducted in each province by the MAFF/NIO for extension staff from the PDAFF, District Agriculture Office (DAO) and representatives from selected ACs that are engaged in rice seed production. A total of 79 participants including 8 women participated in these training.

#### Output 4.3: Enhance business management capacities

- 33. The evaluation of EoIs for the Bulk Handling Study was completed and MAFF/NIO has signed the contract with the service provider in September 2017. The firm is expected to be mobilization in mid-October 2017.
- 34. A study tour was conducted for the Rice-SDP senior management from PMO, MAFF/NIO and each PIO to visit modern rice milling facilities in Cambodia and Thailand. The ToRs for similar study tours for selected rice millers from each province will be conducted once EOIs shortlisting is completed.

#### Output 4.4: Improved Access to and Reduced Cost of Financing

35. No progress has been made yet. This activity will commence in 2018.

#### Output 5: Feasibility Study, Design and Pilot Testing of Weather Indexed Crop Insurance

36. The advertisement and evaluations of EoIs for a service provider for conducting feasibility study (FS) of Weather Indexed Crop Insurance (WICI) has been completed. The contract negotiations with the first ranked shortlisted firm for conducting feasibility study (FS) of Weather Indexed Crop Insurance (WICI) was held in July 2017. Upon ADB NOL, the firm was mobilized in September 2017. The WICI consultants are expected to complete the initial

FS by Q4 2017. Based upon a satisfactory outcome, pilot studies will be designed to commence implementation in 2018.

#### **Output 6: Efficient Program management and Implementation**

37. Preparations and procurements are being made to recruit all necessary individual implementation consultants after the early closure of contract with the implementation consulting firm. Consultant for conducting baseline survey is initiated in July 2017. The PPMS which was developed is being revised to reflect the changes to the GAFSP indicators. Suitable and easy to use monitoring formats are being developed so that the IAs can collect useful data under Rice-SDP. <sup>4</sup> The PMO tried to recruit a Gender and Community Development specialist. After the EOIs evaluation and based on ADB comments, the PMO revised the ToR to separate the position in to Gender Specialist and Community Development Specialist. The ToR for Gender Specialist has been rewritten and advertisement for the recruitment will be made soon.

#### H. GENDER ACTION PLAN

38. Foundation to implement the Gender Action Plan are put in place and the consultants extended technical assistance and training to the appointed GSS Officers in NIOs and PIOs. To this end, the GAP was verified and translated into Khmer. Six gender checklists were also developed in both Khmer and English, covering different agencies and areas of responsibilities within the program. The Gender Checklists enable GSS Officers and other managers to track whether they are meeting the aims, objectives, and indicators which directly apply to their work. The National GSS Specialist also extended one-on-one mentoring and training to each GSS Officer to ensure that they understood their roles and responsibilities, and informally assessed their capacities. The team developed a formal training plan to complement the hands-on guidance and build team morale and include opportunities for cross-learning.<sup>5</sup> As mentioned under para 37, after the early closure of contract of the implementation consulting firm, recruitment of a national gender specialist is now being conducted by the PMO and the consultant is expected to be on board by early 2018.

#### I. ENVIRONMENT AND CLIMATE CHANGE

- 39. The MOWRAM/NIO with support from consultants conducted the FSs for nine priority irrigation sub-project designs, namely in BTB (Prey Sangha, Anlong Run, Ta Mao), PVG (Chamcar Kuoy, Anlong Char, Rumlech, Ansong) and KPT (Chhuk Sach, Ta Soong). The history, status, potential and specific site conditions with the nine sites were found to vary considerably.
- 40. Site visits were conducted including meetings with the stakeholders, familiarization with the specific sub-project details, and issues, and discussion particularly with farmers regarding the recurrent existing weather events, the varieties they are growing, and what they would like to consider and achieve with improved water management including the opportunities for crop diversification. A draft report was prepared summarising the findings and also providing a Tool Kit for Climate Proofing of irrigation systems which can be used for

future reference. A set of specific recommendations are being prepared for each of these subprojects.

#### J. RESETTLEMENT

41. The FS/DD/CS consultant teams that have been recruited by MOWRAM/NIO completed assessments of the resettlement requirements for the nine priority irrigation subprojects including some site visits to assist the Inter-Ministerial Resettlement Committee (IRC) to resolve some issues.

# K. ASSESSMENTS OF RISKS, ASSUMPTIONS AND COMPLAINCE WITH CONVENANTS

#### K1. Assessment of Risks and Assumptions

42. A comprehensive assessment of risks and assumptions was undertaken from the onset of project implementation. This was updated regularly to ensure that risk and assumptions are in line with the status of implementation.

#### K3. Compliance conditions for ADB Program Loan - 3006 (CAM)

- 44. The Program Loan Covenants are established in the loan and grant agreements with further reference to the Development Policy Letter (April 2013) and Appendix 4 Policy Matrix of the RRP (June 2013).
- 45. The Loan Agreement for the Commercial Sector Development Program, ADF 3006 (August 2013) includes a specific agreement under Schedule 3 on the withdrawal of funds:
  - "4. No withdrawal shall be made from the Loan Account for the First Tranche unless ADB is satisfied that the Borrower has met the policy actions for the release of the tranche specified in Attachment 2 to this Schedule.
  - 5. Notwithstanding any other provisions of this Loan Agreement and except as ADB may otherwise agree, no withdrawals shall be made from the Loan Account for the Second Tranche unless ADB is satisfied, after consultation with the Borrower, that (a) sufficient progress has been achieved by the Borrower in the carrying out of the Program; (b) the policy actions that were met for the release of the First Tranche continue to be complied with by the Borrower; and (c) the Borrower has met the policy actions for the release of the Second Tranche specified in Attachment 3 to this Schedule."
- 46. The MAFF/NIO and the TWGs with support from relevant consultants have continued their efforts to achieve compliance with policy conditions for the release of the 2<sup>nd</sup> tranche.

Eight policy conditions are approved and achieved while significant progress has been made on the remaining four policy conditions.

#### L. PROGRAM ISSUES AND REMEDIAL ACTION

47. Some of the issues encountered during the periods are summarised below, together with where appropriate remedial action which is being applied or is required.<sup>6</sup>

- 48. Close monitoring and follow up of service providers is important to get required outputs on time and of good quality.
- 49. Awareness of guidelines both SOP and ADB procedures and their implementation, makes project activity planning a lot easy and enhances speed of implementation.
